
I, ROBERT J. LABRIE, being first duly sworn, say that I am the Vice President, Engineering and Technology, of The Montana Power Company. I have been employed by The Montana Power Company for 32 years. In these years of service, I have been associated with the planning of the Buffalo Rapids #2 hydro-electric development. Based upon my experience, engineering facts known to me, and reports prepared by persons working for me, I can state:

(1) The Montana Power Company, on December 2, 1960, appropriated water to be used at the Buffalo Rapids #2 hydro-electric site;

(2) Since December 2, 1960, a good faith and steady effort has been made to obtain the necessary approvals and permits so that the Buffalo Rapids #2 plant may be constructed; and

(3) This good faith and steady effort will continue until the plant is constructed and the water appropriated in the December 2, 1960, Notice of Appropriation is put to an actual beneficial use.



NOTICE OF APPROPRIATION

Notice is hereby given that The Montana Power Company, a corporation organized and existing under and by virtue of the laws of the State of New Jersey and qualified to do business in the State of Montana hereby gives notice and declares as follows:

1. That it hereby appropriates and claims thirty-five thousand (35,000) cubic feet per second of time of the waters of the Flathead River.

2. The purposes for which said water is claimed and appropriated are for storage and use for a hydroelectric power development and for any and all other beneficial and useful purposes to which said water can be made applicable.

The place of diversion and of intended use of said water is at a dam and power plant to be constructed and located in the Southeast Quarter of the Southeast Quarter (SE $\frac{1}{4}$ SE $\frac{1}{4}$) of Section One (1), Township 21 North, Range 22 West, M.P.M., Lake County, Montana, approximately two and one-half (2 $\frac{1}{2}$) miles downstream from White Clay Creek.

3. The means of diversion of said water will be a concrete dam built across the Flathead River and forebays and penstocks for conveying said water through the generating plant. Said dam will have a crest elevation of approximately 2,715 feet and will create a reservoir approximately twelve (12) miles long. Said forebays and penstocks will be of adequate size to convey water for the operation of turbines having approximately 165,000 horsepower. Said water will be returned to the natural channel immediately below the power plant.

4. The date of appropriation of said water is this 2nd day of December, ~~1954~~ 1960.

5. The name of the appropriator of said water is The Montana Power Company, a corporation.

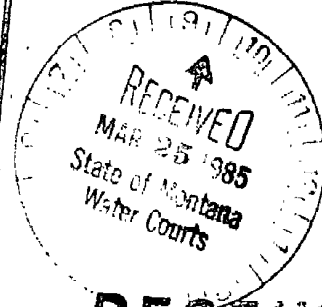

Claim #94408 - Power Generation

Priority date - claimed priority date of April 3, 1920 (filed appropriation by J.E. Bell)

- 1909 - first investigation of power possibilities on Flathead River by U.S. Reclamation Service
- 1916 - Federal Water Power Act passed.
 - Rocky Mountain Power Co. applied for permit to survey Flathead River power sites.
- 1920 - filed appropriation by J.E. Bell.
- 1928 - filed appropriation by Rocky Mountain Power Co.
 - Montana Power Co. aquired land for possible dam construction.
- 1930 - Federal Energy Commission granted permit for construction.
- 1936 - dam construction started.
- 1938 - Kerr Dam completed with water used for first time for power generation.
